**16. Drainage Information:**

Drainage and Hydraulic data was not computed for this project.

**17. Historical Sites or Monuments:**

During the course of this survey there were not any Historical Sites or Monuments encountered.

**18. Paving:**

Paving is Asphalt throughout this project.

**19. Land Ties:**

A. Complete Land tie information was obtained for Section 7 & 8 Township 15 North, Range 20 East and Section 12 & 13 Township 15 North, Range 19 East by conventional field methods as needed to purchase new right of way, including the bounding out of all sections through which the survey centerline passes.

B. All corporate boundary lines, subdivisions and all other property divisions adjacent to and/or crossing the Survey Centerline throughout the project limits were computed mathematically, based upon the best available information. Property divisions include existing right of way lines.
