THIS PROJECT SHALL BE CONSTRUCTED WITHOUT CLOSING THE EXISTING ROAD TO LOCAL AND THROUGH TRAFFIC. SEE STANDARD SPECIFICATIONS FOR MAINTENANCE OF LOCAL AND THROUGH TRAFFIC.

THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY DAMAGE HE MAY INFLICT TO THE EXISTING UNDERGROUND UTILITIES WITHIN THE PROJECT AREA AS A RESULT OF HIS DIGGING, TRENCHING, BORING, ETC.... PRIOR TO DIGGING NEAR THE UTILITIES, THE CONTRACTOR SHALL CALL FOR A LIST OF ALL UNDERGROUND FACILITIES REGISTERED IN THE AREA OF CONSTRUCTION LISTED WITH THE FOLLOWING AGENCIES:

- (2) PRICE BID FOR THIS ITEM SHALL INCLUDE THE COST OF INSTALLING 27 - 30' MH POLES AND 30 - 16' MH POLES AS SHOWN IN THE PLANS.  
  
THE POLES TO BE SUPPLIED ON THIS PROJECT SHALL BE IN ACCORDANCE WITH THE LIGHTING DETAILS IN THESE PLANS, WHICH ARE IDENTICAL TO THE LIGHT POLES SUPPLIED ON PROJECT 180. THE LATEST STANDARDS AND SPECIFICATIONS FOR PROJECT 180 ARE TO BE USED ON THIS PROJECT. - (5) QUANTITY SHOWN IS FOR THE INSTALLATION OF 400 WATT HPS TYPE IV, MEDIUM, SEMI-CUTOFF DISTRIBUTION ROADWAY LUMINAIRES SIMILAR TO THE HOLOPHANE MONGOOSE LUMINAIRE MODEL G400HP48LSCHGB, OR AN APPROVED EQUAL.  
  
THE LUMINAIRES TO BE PROVIDED ON THIS PROJECT SHALL BE BLACK POWDER COAT, PELCO POWDER COAT NUMBER P-33.

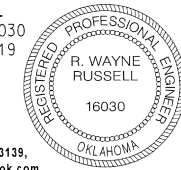
