Notice is hereby given that the Board of Stephens County Commissioners will accept bids for a Bridge Project for Stephens County Commissioner, District #3, Comanche, OK. Bridge Project will be for a Turn Key Job, **(for labor only)** on a 26'X 40' Concrete and Steel Non Composite Structure. Stephens County will furnish All materials. Contractor will remove the existing bridge structure, and Stephens County will retain existing bridge stringers, if salvageable.


Must have Worker's Compensation on applicable employees, and must provide verification of same. Each bid shall be accompanied by a Certified or Cashier's Check or Bid Bond equal to 5% of the bid, made payable to the County Clerk of Stephens County, Oklahoma, as proposal guaranty. Checks for unsuccessful bidders shall be returned after bid opening. Upon award of bid, successful bidder will be required to furnish a performance bond.

Bids will be opened on Monday, the 29<sup>th</sup> day of April, 2013 at 10:00 a.m. in the County Commissioners' Office during the Board's regularly scheduled meeting. Bids shall be presented and/or filed up to that time in the Stephens County Clerk's Office, both offices being in the Stephens County Courthouse, 101 S 11<sup>th</sup>, Room 203 Duncan, Oklahoma. All bids received after that time will be rejected. All bids must be in a sealed envelope clearly marked "BID" on the outside.

The Board of County Commissioners will review all bids submitted and select the bid that best meets or exceeds the required minimum specifications. The Board reserves the right to reject any and all bids that are not satisfactory.
