CONSTRUCTION NOTES**

Sealed bids will be received by the Murray County Clerk's Office at 1001 W Wyandotte, Sulphur, OK 73086, until 10:00A.M. on Monday, January 4, 2016 at which time said bids will be opened and read aloud for the 2016 County Road Improvement Projects, to wit:

A mandatory pre-bid meeting will be held on Tuesday, December 22, 2015 at 1:00 P.M. at the Murray County Court House Commissioners' Offices.

A bid bond in the amount of 5% of the total amount bid shall be attached to all bids as a guarantee that the successful bidder will, within ten (10) days of the date of notice of award, enter into contract and file the required bonds. No bidder may withdraw his bid within 45 days after the actual date of the opening thereof.

The Owner reserves the right to reject any or all bids, waive any irregularities or technicalities without assigning any reason therefore, and to make the awards in the best interest of the Owner. Bids are solicited and a contract award will be made pursuant to the Public Competitive Bidding Act of 1974 as amended (Title 61, O.S. 1981, Sections 101-136 et seq.)

All material specifications shall comply with the 2009 Oklahoma Standard Specifications for Highway Construction. Special Provisions govern over standard specifications and supplemental specifications.

The Project shall be constructed without closing the road to local and thru traffic.

Bidders shall fully inform themselves of the nature of the work and conditions under which it will be performed. The Contractor shall adopt methods consistent with good construction practices and shall take all necessary precautions to prevent damage in existing right of way. Any damage due to the Contractor's negligence shall be repaired at the Contractor's expense to the satisfaction of the County's Representative.

The price bid on ALL items shall include all materials, labor, equipment and incidentals, including maintenance bond, payment bond and performance bond, necessary to complete the work.

Prime oil (AEP) application rate is at 0.2 gallons per square yard.

Contractor to furnish fuel, equipment and operator for reclaiming existing base (Bomag) 6" to 8" in depth at various widths on the following:

- Two (2) miles on Hammett Road
- One (1) miles on 14th Street
- Two (2) miles on Buel Green
- One (1) mile on Caldwell Road
- One (1) mile on West Palmer

Contractor to furnish fuel, equipment, operators and CRS-2 to apply a single oil and chip on the following roads:

Hammett Road	2 miles	Hwy 177 to Round Tree Road
Caldwell Road	1 miles	Hwy 177 to Swayback Road
14th Street	3.5 miles	Suzie Dr to Buel Green Road
Palmer Road	4 miles	Turnpike to Walnut Street
Koller Road	1.5 miles	Hwy 7 to Palmer Road
Buel Green Road	4 miles	Hwy 177 to Burnside Road
Round Tree Road	1 mile	Hammett Road to Oak Creek Road
Oak Creek Road	1 mile	Round Tree Road to Trett Slab Road

Oil, CRS-2 applied at .40 gallons per square yard

5/8" chips or 3/8" chips applied at 30 pounds per square yard

Chips will be furnished by the County and placed in stockpiles designated by the County
County forces will prepare the roadways to accept oil and chips surfacing

This contract can be terminated for convenience by the Owner at any period during the Project without any additional cost to County other than units installed.

A certificate of insurance will be required before work begins showing that contractor has workers compensation and public liability insurance as required by Oklahoma Law.
