

SPECIFICATIONS FOR ASPHALT LAID IN PLACE:

- A. 2" Type C Asphalt overlay on 0.7 miles on Coral Reef Road. The road is approximately 18' wide.
- B. 2 ½" Type C Asphalt overlay on 2.2 miles on EW 5700 Road (Benight Road) from Highway 48 to NS 36800 Road. This road is approximately 22' wide.

PROJECT MUST BE COMPLETED THIRTY (30) DAYS FROM ACCEPTED DATE OF CONTRACT.

NOTE: ROADS ARE ALL LOCATED APPROXIMATELY 3-15 MILES WEST OF THE ARKANSAS RIVER BRIDGE ON HIGHWAY 412; APPROXIMATELY 25 MILES WEST OF SAND SPRINGS, OKLAHOMA.
