**On the original Bid Form located on page 5 of the bid packet, insert “See Addendum #1 for Bid totals” in the Base Proposal section.**

**This paragraph is altered and replaced as follows:**

**Painting of the Centerline striping is estimated with stripe thru the entire length of the project. The contractor shall lace stripe to include no passing zones as directed by the road foreman.**
