**SPECIFICATIONS FOR ASPHALT LAID IN PLACE:**

A. 2" Type C Asphalt overlay with SS-1 tack oil on 5750 Road from Highway 99, West 5280 feet to 36000 Rd. The road is approximately 32 feet wide at Highway 99 for 75 feet heading west tapering to 22 feet wide.

PROJECT MUST BE COMPLETED THIRTY (30) DAYS FROM ACCEPTED DATE OF CONTRACT.

NOTE: ROADS ARE ALL LOCATED IN THE TOWN OF JENNINGS, OKLAHOMA.

VENDOR WILL FURNISH ALL NECESSARY EQUIPMENT, LABOR, AND MATERIALS, NEEDED FOR ROAD PREPARATION, REMOVAL OF GRASS AT EDGE OF ROADWAY, AND TACK COAT.
