Welcome to the Public Hearing for the Proposed Widening of Covell Road from State Highway 74 to Interstate 35 November 13, 2008

The City of Edmond and Oklahoma County District 3, in cooperation with the Oklahoma Department of Transportation (ODOT), proposes to widen and reconstruct Covell Road from State Highway 74 to Interstate 35. The purpose of this hearing is to answer questions and receive comments regarding that proposal and the Environmental Assessment that has been done on the project.

Project Summary

NEED FOR PROJECT

• Edmond and Oklahoma County recognize the need for an east-west route connecting SH74 and I-35 to accommodate existing traffic and anticipated traffic growth.

PROPOSED PROJECT SCOPE

The proposed project extends approximately 9.25 miles from roughly State Highway 74 to I-35. The
proposed project segment located within the Corporate Limits of the City of Edmond (7.25 miles) includes
widening the existing two-lane Covell Road facility to a four-lane separated boulevard with ADA compliant
multipurpose paths on both sides. The proposed project segment located within the unincorporated area of
Oklahoma County (2 miles) includes widening the existing roadway to a four-lane undivided curb and gutter
facility. Covell Road will be built in phases due to the length and costs of the overall project.

ENVIRONMENTAL REVIEW AND ANALYSES

- Proposal consistent with local, state and federal planning for the area.
- Six (6) relocation impacts are possible.
- Proposed right-of-way will be secured in accordance with the Uniform Relocation and Real Property Acquisition Policy Act of 1970, as amended.
- Environmental Assessment completed February of 2006 including:
 - o Traffic Noise Analysis Report
 - o Wetland and Waters of the United States Impact (none identified)
 - Endangered Species Impacts (none identified)
 - o Floodplain Impacts and Rechannelization (all proper permits will be obtained)
 - o Historical and Archaeological Resources Impacts (none identified)
 - o Hazardous Waste Sites/Underground Storage Tanks (none in corridor)
 - o Air Quality (no impacts)
 - A letter soliciting comments related to the anticipated social, economic and environmental effects was mailed to 48 local, cities, county, state and federal agencies, organizations and individuals.

PROPOSED SCHEDULE

- Approval of final environmental document by ODOT and FHWA Spring/Summer 2009
- Final construction plans, right-of-way plans, right-of-way acquisition, and utility relocations ... Ongoing
- Begin construction Santa Fe to Thomas...... Federal Fiscal Year 2013*
- Balance of corridor will be scheduled as funds are identified. Every effort will be made to keep roadway open during construction.
