All interested persons are given notice that the Oklahoma Department of Transportation (ODOT), in cooperation with the Federal Highway Administration (FHWA) will conduct a public hearing regarding proposed improvements to correct operational deficiencies on Interstate 40, between Interstate 240 and Choctaw Road in Oklahoma City, Oklahoma County. The proposed improvements include reconstruction of I-40 between I-240 and Choctaw Road, modification of the Choctaw Road interchange and improvements to Choctaw Road in the area of the interchange.
