The meeting is intended to provide information on the project scope and status and to solicit public input.

PROJECT SUMMARY

NEED FOR PROJECT

 The primary purpose of the project is to improve safety by adding shoulders and other design features along the roadway.

PROPOSED PROJECT SCOPE

• The cities of Yukon and Oklahoma City and ODOT propose to reconstruct this segment of roadway to a four-lane facility from SH-66 north to Wagner Road. An interim solution will be to reconstruct SH-4 to a two-lane roadway with 8-foot shoulders from Wagner Road to Wilshire Boulevard. As traffic counts increase over time, another project will be scheduled to four-lane SH-4 from Wagner Road to Wilshire Boulevard. The project from Wilshire Boulevard north to SH-3 will be a two-lane facility with 8-foot paved shoulders.

ENVIRONMENTAL CONSEQUENCES OF THE PROJECT

- Conversion of Prime Farmland to Transportation Use
- Increase in Traffic Noise Levels
- Loss of Wetlands and Streams
- Potential to Encounter Contaminated Soil and/or Groundwater during Construction
- Temporary Road Closures

ESTIMATED DATES

- Environmental clearance; fall 2012.
- Right-of-way acquisition will begin winter 2012 and end spring 2013.
- Utility relocations; spring 2013 through fall 2013.
- Construction begins; spring 2014.
