2	Construct a landscaped pedestrian bridge over I-40 west of Union Station. ((FEIS, pg. 5-54)	Completed	With input from City and 2009 FEIS Skydance Bridge reevaluation completed this structure was constructed in 2011.
3	Acquire additional right-of-way bordered by Robinson, Walker, SW 9th and SW 10th to provide a park. (FEIS, pg. 5-54)	Started/Ongoing	All of the required 44 parcels for the park area have been acquired (see Table II). OKC has taken lead role and is moving forward in working with local residents and various groups regarding the park improvements.
4	Conduct building condition surveys prior to, during and after construction for the Little Flower Church, Riverside School, Wesley Center and Union Station Train Depot. (FEIS, pg. 5-12)	Started/Ongoing	Pre-construction building condition surveys completed on the four structures and a report submitted to ODOT in August 2002. A second report was completed and submitted to ODOT Feb 2008. As of 2/29/12, the final post construction survey is needed to be completed.
5	Conduct additional noise mitigation studies on areas indicated to have potential noise impacts. (FEIS, pg. 5-11)	Completed	A noise analysis component was included in the engineering studies contract. A final Traffic Noise Abatement Report was submitted to ODOT 4/20/04 and a re-evaluation completed 1/9/08. Mitigation was determined not reasonable for Carver Community neighborhood; not feasible at Riverside Neighborhood and unnecessary at Westlawn Gardens Neighborhood due to project design changes.
6	Formally notify the City of OKC that the LCDA has concerns regarding policing in the area. Request that OKC give special consideration for increased presence. (FEIS, Vol II, Response to Comments pg. 19)	Completed	ODOT sent letter to OKC regarding this commitment and the request on 11/14/02.

As of 2/29/12, no noise complaints received after the mainline was opened recently. This commitment is considered open until the boulevard is completed and open to traffic.

S-1)	Not Started	This commitment is being carried forward in the design aspects and in discussions with the enhancements group. Project meeting held 2/29/12 to discuss updated design and project scheduling. This commitment is not considered complete until construction is complete.
