Relocation of US Highway 62 and State Highway 51, Cherokee County

Remove US Highway 62 and State Highway 51 designations from State Highways 10 and 82, beginning at the intersection of Choctaw Street and Muskogee Avenue in Tahlequah and extending northerly and easterly to the intersection of Downing Street and Water Street, a distance of 0.4 mile.

Add to the State Highway System a segment of road in Tahlequah to be designated as US Highway 62 and State Highway 51 beginning at Muskogee Avenue and extending easterly on Choctaw Street, thence northerly on Water Street to Downing Street, a distance of 0.4 mile.

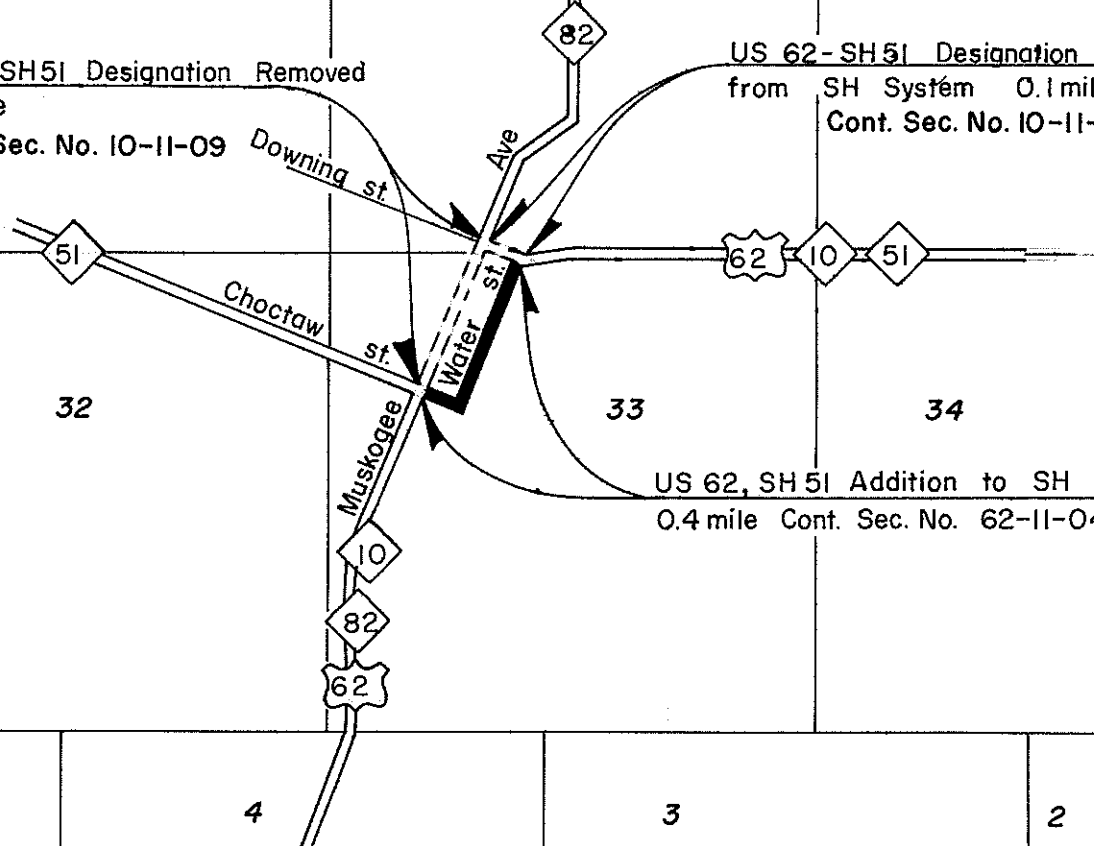
