SUBJECT: Revision to the State Highway System -
Relocation SH 59
COUNTY: McClain

The following revision is necessitated by the relocation of SH 59 south of Wayne.

Add to the State Highway System a segment of new highway to be designated as SH 59, beginning at its junction with the existing road south of Wayne and extending east to a connection with US 77 southeast of Wayne, a distance of 0.41 mile.

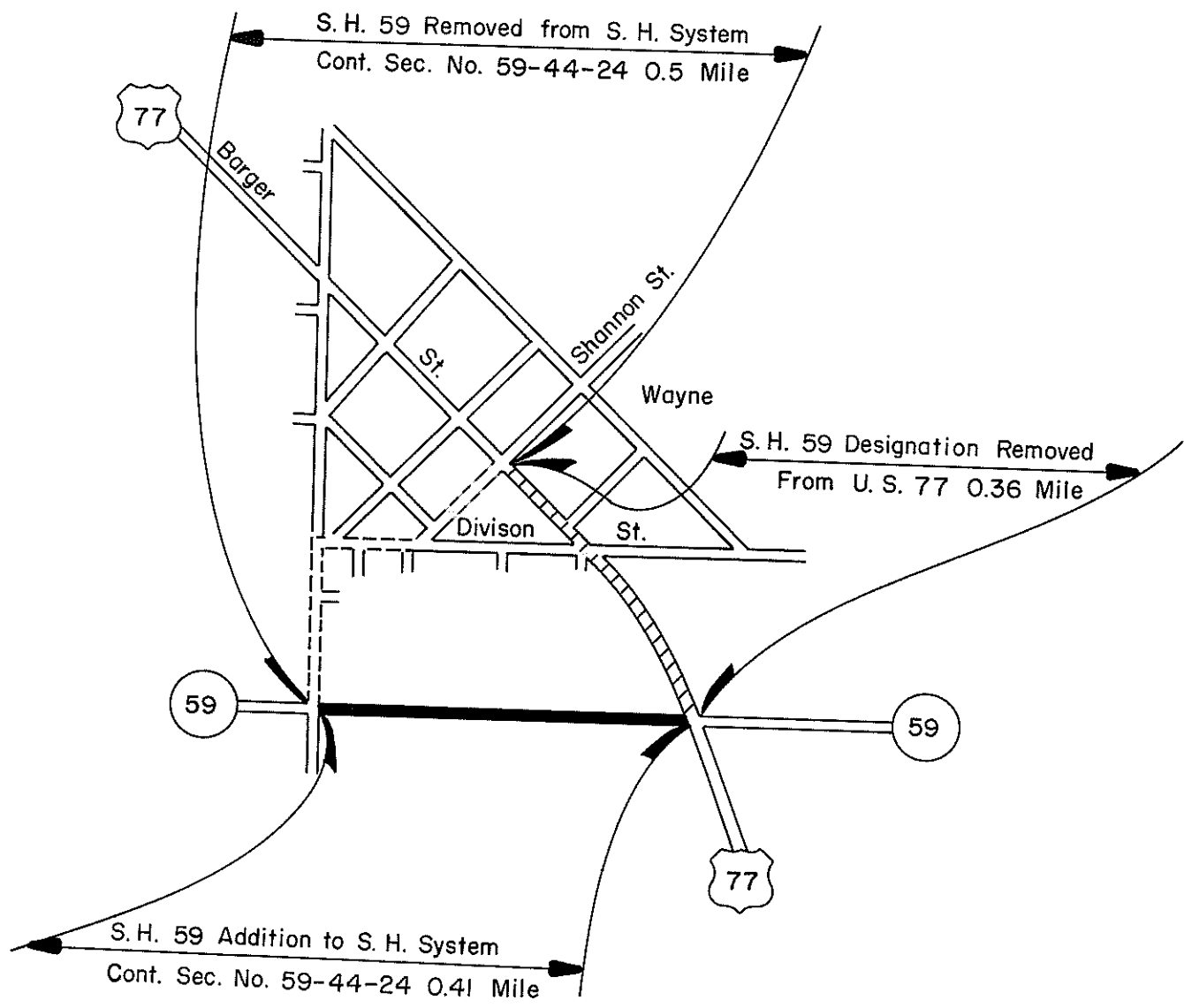
Delete from the State Highway System a 0.50 mile segment of road designated as SH 59, beginning at a tie with the new location south of Wayne and extending northeasterly in Wayne to a junction with US 77 at the intersection of Shannon and Barger Streets. This segment of old SH 59 will be transferred to the appropriate local jurisdiction for further maintenance or abandonment.

Remove SH 59 designation from US 77 beginning at its junction with new SH 59 and extending north .36 mile to Shannon Street in Wayne.

This revision to the State Highway System will become effective upon the approval of the State Transportation Commission.

Removal Public Hearing was held June 29, 1982.

 Cont. Sec. No. 59-44-24 0.5 Mile

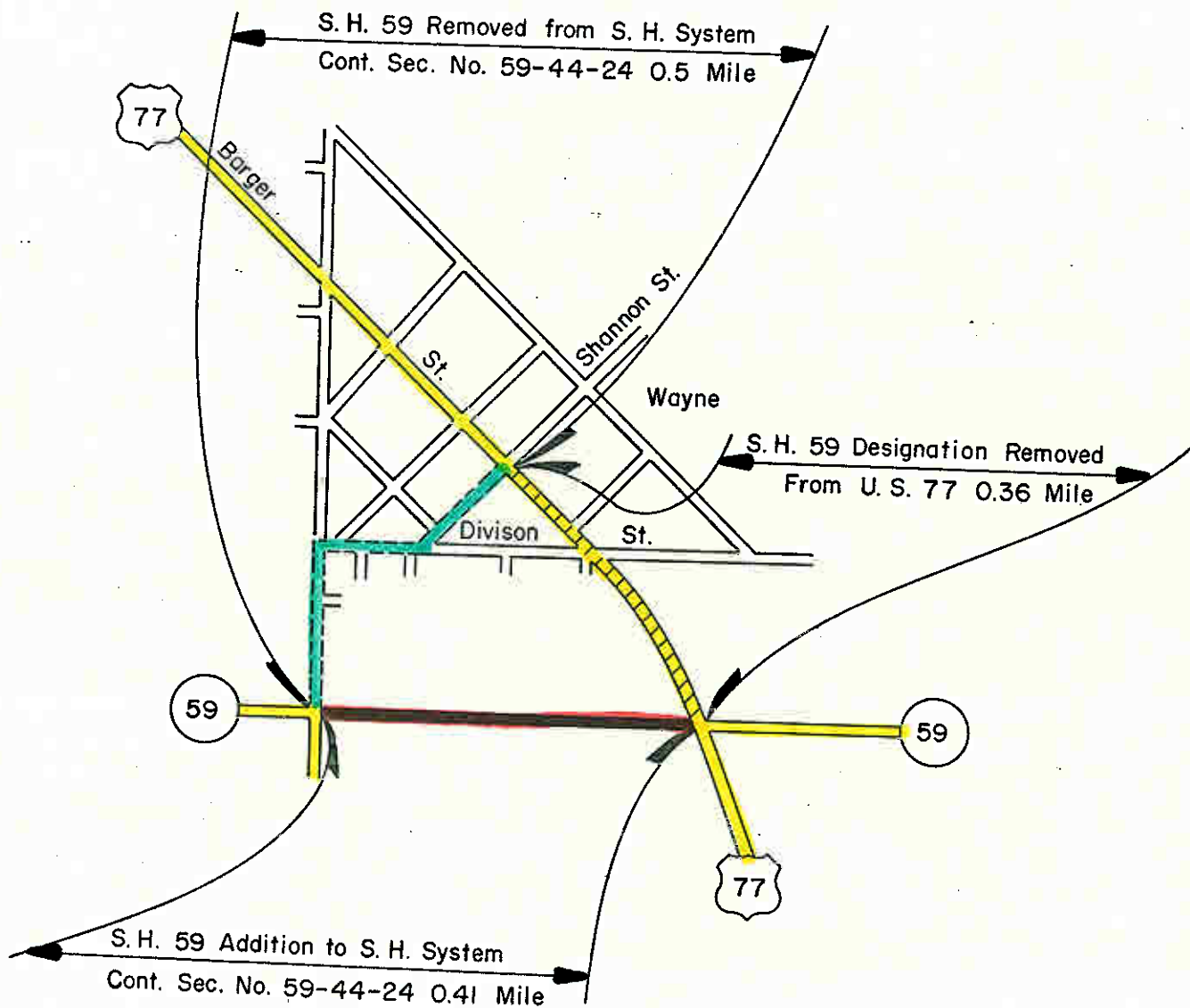
S.H. 59 Designation Removed


