

## **FOREWORD**

The Oklahoma Department of Transportation is pleased to provide a more formalized 2013-2016 Asset Preservation Plan. The Plan encompasses State, Federal and Interstate highway asset preservation activities as proposed through a validation and consideration process led by our eight Field Division Engineers. It is worthwhile to note that this edition directly incorporates aspects of Governor Mary Fallin's Bridge Improvement Plan and augments the 2013 - 2020 Eight Year Construction Work Plan in the calculated reduction of structurally deficient bridges.

The preservation of our existing transportation system is an absolutely critical part of the Department's mission. In the past many of the improvements that could have extended the life cycle of our facilities and structures have gone unaddressed. Timely preventative maintenance was forgone for a variety of reasons including a general lack of funding compounded by a perceived need to expand the system at the expense of preservation activities. Inevitably, the lack of investment in asset preservation has contributed to the enormous backlog of critically needed road and bridge improvements. While a meaningful investment in asset preservation has been difficult if not impossible to achieve, in recent years new resources provided through the efforts of the Legislature and Governor have brought these deficiencies into focus.

Much like our Eight Year Construction Work Plan, a more detailed Asset Preservation Plan provides us with insight into the investment strategies for our available transportation dollars. As our preservation capabilities have expanded, it has become increasingly more important to understand how our preventative maintenance interacts with and compliments the projects described in the Construction Work Plan. In addition, we have an inherent responsibility to provide the people of Oklahoma with a more complete description of the anticipated activities of the Agency. The work described in these Plans has already been fully vetted and determined to represent the wise investment of our available resources.

In recognizing the value and similarities of the Construction Work Plan and the Asset Preservation Plan, we must also recognize the reactionary nature of preservation activities. The need for preventative maintenance is most directly influenced by the unpredictable forces of Mother Nature and our history of maintenance deferral. The condition of our pavements and bridge structures can change dramatically in short windows of time. Because asset preservation is an inexact science, the Asset Preservation Plan is presented as informational and should be considered to be flexible and subject to regular re-prioritization and adjustment as dictated by the ever changing deterioration curves.

On behalf of the Department of Transportation, thank you for the opportunity to present this information and for your continued support in the construction, care and maintenance of Oklahoma's transportation infrastructure.

# Budgetary Projections

## ASSET PRESERVATION PLAN - SFY 2013 through SFY 2016

The budgetary projections utilized for the basis of the fiscally responsible and financially balanced Asset Preservation Plan were established through a systematic evaluation of the Department's anticipated State and Federal revenues and expenditures. Projections were performed for State Fiscal Years 2013 - 2016 with the State Fiscal Year defined as beginning July 1<sup>st</sup> and ending on June 30<sup>th</sup>. The budgetary projections only address funding that has been historically and/or categorically committed to State asset preservation.

For the purposes of the initial projections, an estimated budgetary baseline amount of \$115 million was utilized as the benchmark for SFY 2013. This baseline amount provides \$75 million for roadway preservation and \$40 million for bridge preservation and engineering statewide.

A formula that includes consideration for conditions and that is influenced by the lane miles in each Field Division is applied to the roadway asset preservation baseline amount to insure an equitable geographic distribution of each Fiscal Year projection. Likewise, a formula that is focused on the square footage of bridge deck in each Field Division is applied to the bridge preservation baseline amount to achieve a similar distribution of the available bridge asset preservation funds.

# BALANCING PROCESS

# Balancing Process

The development of Asset Preservation Plan begins with our Field Division Engineers and is guided by their knowledge of the transportation needs and priorities in their respective Divisions. They and their staff work to maintain an understanding of the condition of the roads and bridges in their areas of responsibility.

Their daily experiences and knowledge of the transportation assets is then coupled with the careful consideration of the improvements anticipated to be delivered through the Eight Year Construction Work Plan (CWP). It is important to maintain a clear perspective of the project development schedule for the improvements encompassed by the CWP. The timing of preservation activities is paramount in order to avoid potential project conflicts and to maintain the transportation system in a serviceable and manageable condition until any planned larger scope improvements can be achieved.

The Asset Preservation Plan is a function of each Field Division's condition assessments of the highway network, the associated critical needs and the work to be accomplished in the CWP along with the anticipated preservation budgets. Annually, the Field Division Engineers review and validate the scheduled Asset Preservation Plan projects and target their needed preservation activities in accordance with the projected funding availability. The Asset Preservation Plan is crafted with foremost consideration for maintaining the integrity of the Field Division Engineer's transportation system management strategy and project priorities. In addition, the balancing process seeks to insure that each Field Division is allocated available funding in accordance with the aggregate budget projections.

## **ADDITIONAL CONSIDERATIONS**

System preservation can be dramatically influenced by the unpredictable effects of weather, deterioration and ever changing traffic patterns. Therefore, asset preservation activities are somewhat more reactionary in nature than the calculated improvements encompassed in the Construction Work Plan. Some re-prioritization of the preservation activities depicted herein is acceptable and expected.

The Asset Management Plan is balanced within these guidelines and has been determined to be an equitable representation to the satisfaction of the Department and the Transportation Commission.
