#### Stimulus Sidewalk Project Information (Prequalification requirements has been waived for these projects)

Three (3) Stimulus Sidewalk Projects scheduled on the Special December 17, 2009 Bid Opening. These projects are composed primarily of the construction of sidewalk, handicap ramps, and landings. This type of construction requires strict compliance with regulations which set specific guidelines for grades, slopes, widths, heights, and clearances for pedestrian access in order to comply with the Americans with Disabilities Act (ADA). It is the bidder's responsibility to be well versed in the requirements of ADA compliant pedestrian facilities.

Plans and proposal forms may be ordered from the Office Engineer Division, Oklahoma Department of Transportation Building, 200 N.E. 21st Street, Oklahoma City, Oklahoma 73105. Cost of bidding documents are \$50.00 + tax for each bidding proposal. "Sample" proposals may be obtained free of charge.

Companies must provide a bid bond equal to 5% of the bid made payable to the State of Oklahoma Department of Transportation, as a proposal guaranty.

The Scheduled Bid Opening is 10:30 a.m. December 17, 2009. No proposal for construction or maintenance work of the Department will be issued to any contractor after 10:30 am on the working day preceding opening of bids for any contract.
