## 137. Engineering Contracts

a) Lincoln County - E.C. 875 to Brawley Engineering for final design plans for constructing roadway and bridges on US-62 over Sandy Creek, east of the SH-18 junction. Total engineering costs \$80,000.
b) Lincoln County - E.C. 876 to C. H. Guernsey and Company for final design plans for constructing the roadway and bridge on SH-18 over Quapaw Creek, north of the US-62 junction. Total engineering costs $\$ 100,000$
c) Lincoln County - E.C. 866 to Garver Engineers for final design plans for constructing roadway and bridges on SH-18 over the Deep Fork River south of Chandler. Total engineering costs \$200,000
d) Lincoln County - E.C. 867 to Bucher, Willis \& Ratliff for final design plans for constructing the roadway and bridges on SH-99 over the Deep Fork River. Total engineering costs \$240,300

138. Supplemental Engineering Contracts
a) Woodward County - E.C.103G, Supplemental No. 1. Based on requirements of recent Hydraulic Study, a modification to the scope of the project is required. Cobb Engineering will prepare modification, bringing the total engineering contract costs, including supplementals, to $\$ 1,065,400$. ( $80 \%$ federal funds and $20 \%$ soft match credit)
b) Sequoyah County - E.C. 105G, Supplemental No. 1. Additional geotechnical studies not in the original scope of work are required on this project for cut and em bankment section soils survey. USInfrastructure of Oklahoma, Inc., will conduct additional geotechnical studies for a fee of $\$ 21,200$ which brings the total engineering costs, including supplmentals, to $\$ 533,200$. ( $80 \%$ federal funds and $20 \%$ soft $m$ atch credit)
c) Seminole County - E.C. 610G, Supplemental No. 3. The Department has negotiated a supplemental agreement to provide additional services for channel modifications, additional right-of-way requirements associated with the channel modifications and details for necessary repairs on an existing bridge (SH-99 south of I-40). Wilson and Company will provide these additional services for a fee of $\$ 10,000$. Total engineering costs, including supplements, is \$579,000. (80\% federal funds with $20 \%$ soft match credit)
d) Oklahoma County - E.C. 728, Supplemental No. 1. Roadway safety improvements on I$40 /$ Interstate 44 Interchange ("K" Interchange). In addition, engineering services, labor, equipment and incidentals are required to provide roadway lighting plans. Poe \& Associates will provide engineering services for a fee of $\$ 145,100$ which brings the total engineering contract costs, including supplementals, to $\$ 595,100$. ( $90 \%$ federal funds and $10 \%$ soft match credit)
