The Department has selected the engineering firm of FBS Engineering, Inc., to provide Snooper Fracture Critical Inspections, and Bucher, Willis & Ratliff Corporation to complete the Ground Fracture Critical Bridge Inspections statewide. The total not to exceed rate of this contract is \$665,000; negotiated lump sum fees are Bucher, Willis & Ratliff Corporation \$400,000 and FBS Engineering, Inc., \$265,000.

b) Beckham County - Commission District V (E.C. 896)

The Department has selected Engineering Services & Testing, Inc., to prepare final design plans for the I-40 business district (I-40B) through Elk City. Negotiated fee is \$ 316,000.

## 121. Supplemental Engineering Contracts

#### a) Statewide - Bridge Standard Drawings (E.C. 623 Supplement No. 1)

The Transportation Commission previously authorized White Engineering Associates, Inc., to prepare final Bridge Standard Drawings. The Department and consulting firm have agreed to an adjusted engineering fee of \$298,000. This brings the total engineering contract cost, including supplementals, to \$718,000.00. Funding will be with 80% federal funds and 20% soft match credit.

## b) Sequoyah County - Commission District I (E. C. 584 Supplement No. 1)

The Transportation Commission previously authorized Robert B. Hendrick & Sons Co, Inc., to prepare final design plans for the replacement of the existing bridge over Little Lee Creek and approaches on SH-101. This supplemental agreement is to provide for bridge revisions and roadway modifications to accommodate the new channel bank alignment and to prevent further bank deterioration. The adjusted engineering fee is

\$15,000.00. This brings the total engineering contract cost, including supplementals, to \$144,000.00. Funding will be with 80% Federal funds and 20% soft match credit.

### c) Oklahoma County - Commission District IV (E. C. 728 Supplement No. 3)

The Transportation Commission had previously authorized Poe & Associates, Inc., to prepare final design plans for improvements to the I-40/I-44 Interchange ("K" Interchange). This supplemental agreement is to provide for additional roadway, survey and bridge design. The adjusted engineering fees are \$132,400. This brings the total engineering contract cost, including supplementals to \$923,800. Funding will be with 90% federal funds and 10% soft match credit.
