27. Engineering Contracts
a) Statewide - All Districts (E.C. 880 County Bridge Standards)

Engineering Services \& Testing, Inc., has been selected to prepare detailed county bridge standards for span structures, in accordance with the AASHTO Load and Resistance Factor Design (LRFD) Bridge Design Specifications. Estimated cost to prepare County Bridge Standards in English units is $\$ 600,000.00$. Funding will be $80 \%$ federal funds with $20 \%$ soft match credit.
b) Wagoner County - Commission District I (E.C. 1011A)

Garver Engineers, LLC has been selected to prepare construction plans for improvements to existing lanes on SH-51 from Coweta east to Wagoner, including bridge and approach roadway replacement over the Verdigris River. The negotiated fee for preparation of the construction plans is $\$ 369,000.00$. A construction project in this corridor is in the 8 Year Construction Work Plan with a scheduled letting date of FFY 2009. The total estimate for construction of this project is $\$ 5,643,000.00$. Funding will be with $80 \%$ federal funds and $20 \%$ soft match credit.

The Benham Companies, Inc., was previously authorized to prepare bridge standards for Reinforced Concrete Box (RCB) Culverts in accordance with AASHTO Load and Resistance Factor Design (LRFD) Bridge Design Specifications. This supplemental agreement is needed to complete the inventory of the Standard RCB Drawings. Adjusted engineering fees for this supplement total $\$ 300,000.00$. This brings the total engineering contract cost, including supplementals, to $\$ 630,000.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
b) Kay County - Commission District IV - (E.C. 925, Supplement No. 2)

Tetra Tech FHC, Inc., was previously authorized to provide design analysis, constructions plans and survey for the development of the Tourist Information Center in Kay County. This supplement is for work required for the construction of new exit and entry ramps, environmental studies, water quality drilling and testing, right-of-way investigations and additional construction management tasks for the facility. Adjusted engineering fees for this supplement total $\$ 142,458.00$. This brings the total engineering contract cost, including supplementals, to $\$ 481,758.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.

## ITEM PRESENTED BY THE DIRECTOR - Mr. Ridley

## 33. Director's Report

Mr. Ridley discussed the recent tragedy where a local citizen was fatally injured in a traffic accident at the intersection of SH-102 and Belcher in Pottawatomie County. The Director pointed out that Item 20.a) on the Consent Docket and a project in our 8 Year Construction Work Plan addressed this bad situation in Pottawatomie County.

State funding and passage of HB 1078 would allow us to achieve a base line for funding and, under proposed legislation, our funds would continue to grow. Also the determination of critical needs projects would be performed by ODOT personnel.

The Director discussed Governor Henry's plan for Transportation and pointed out that not only extra funding would be generated for our Agency, but also that the money would come from a revolving fund rather than an appropriated fund - they money would come directly to us.

The constitutional amendment proposed by Governor Henry would protect monies coming into the Department, and distribution of this money could not be changed by future politicians.

At the time Governor Henry came into office there were 145 bridges in the 8 Year Construction Work Plan; today there are 306 State bridge projects in the 8 Year Construction Work Plan. Director Ridley referred to the State map showing load posted, structurally deficient/functionally obsolete bridges. If Governor Henry's transportation bill passes, 137 of these bridges will disappear from the map within 6 years.
