Caddo County - Commission District VII (EC-1138)

The Department has selected Poe & Associates, Inc., to perform engineering and drafting services for the reconstruction of SH-152 near the City of Binger. The negotiated fees total \$481,000.00. The project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2009. The total estimate for construction of this project is \$6,982,857.00. Funding will be 80% federal and 20% soft match credit.

- 6. Supplemental Engineering Contracts
 - a) Pottawatomie County Commission District III (EC-1035, Supplement No. 3)

Clour Engineering was previously authorized to prepare final design plans to reconstruct a portion of Kickapoo Street from the Kickapoo Spur to MacArthur in Shawnee. This supplement is for additional engineering services necessary to proceed with right-of-way mapping, based on the final construction plans. The City of Shawnee will be responsible for acquisition and clearance of right-of-way. The total not to exceed amount of this supplement is \$65,201.00. The total engineering contract cost, including supplements, is \$888,201.00. The total estimate for construction of this project is \$6,200,000.00. Funding will be with 80% federal funds and 20% soft match credit.

b) Dewey County - Commission District V (EC-125G, Supplement No. 2)

Cobb Engineering Company was previously authorized to prepare final design plans for roadway and bridge projects within the US-270/SH-3 corridor. This supplement is for design modifications to those projects. The adjusted engineering fees total \$193,900.00. The total engineering contract cost, including supplementals, is \$1,158,700.00. The total estimate for construction of these projects is \$33,811,188.00. The projects are scheduled for construction in FFY 2007, 2008, 2010 and 2011. Funding will be 80% federal funds and 20% soft match credit.

c) Texas County - Commission District VI (EC-897, Supplement No. 2)

Brawley Engineering Corporation was previously authorized to prepare final design plans for the US-54 corridor. This supplement is for design and right-of-way modifications to this project due to a railroad crossing closure in this corridor. The adjusted engineering fees total \$9,800.00. The total engineering contract cost, including supplementals, is \$860,800.00. This project is scheduled in FFY 2008 in the 8 Year Construction Work Plan. The total estimate for construction of this project is \$27,308,667.00. Funding will be 80% federal funds and 20% soft match credit.

d) Delaware County - Commission District VIII (EC 924, Supplement No. 1)

Tetra Tech FHC was previously authorized to prepare final design plans for the replacement of the SH-127 bridge over Drowning Creek and realignment of the approach roadways, northeast of Jay. This supplement is for design modifications to this project. The adjusted engineering fees total \$59,000.00. This brings the total engineering contract cost, including this supplement, to \$234,200.00. Funding will be with 80% federal funds and 20% soft match credit. This project was advanced from 2008 and let for construction in September 2007.

e) Osage County - Commission District VIII - Gilcrease Expressway

At the request of INCOG and the City of Tulsa, the Transportation Commission authorized Tetra Tech FHC to prepare functional design and right-of-way plans for a segment of the proposed Gilcrease Expressway from LL Tisdale Parkway to Edison Street. This supplement is for additional engineering services to proceed with final plan development, in phases, for the initial two-lane construction. The total not to exceed amount of this supplement is \$4,240,185.53. The total engineering contract cost, including this supplement, is \$6,263,556.45 INCOG has approved the use of allocated STP funds to fund 80% of the contract amount, and the City of Tulsa has agreed to provide 20% matching funds.
