## ITEMS PRESENTED BY THE DIRECTOR OF ENGINEERING - Mr. Streb

## 126. Supplemental Engineering Contracts

EST, Inc., was previously authorized to perform Fracture Critical Bridge Inspections. This supplement is for special inspections that are beyond the original scope of work. The total not to exceed amount of this supplement is $\$ 150,000.00$. The total contract cost, including supplements, is $\$ 463,000.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
b) Payne County - Commission District IV (EC 1037, Supplement 1)

EST, Inc., was previously authorized to provide engineering services and construction plans for the improvements on $\mathrm{SH}-33$. This supplement is for additional engineering services and the total not to exceed amount of this supplement is $\$ 530,000.00$. The total contract cost, including this supplement, is $\$ 1,223,000.00$. Construction projects are included in the 8 Year Construction Work Plan with scheduled letting dates beginning in FFY 2009. The total estimate for construction of this project is $\$ 20,369,212.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
c) Blaine County - Commission District V (EC 1038, Supplement 1)

Cobb Engineering Company was previously authorized to provide engineering services and construction plans for the improvements on US-281/US-270. This supplement is for additional engineering services necessary for a new project scope and to provide the required plan sets to accommodate multiple construction projects to complete this corridor. The total not to exceed
amount of this supplement is $\$ 124,900.00$. The total contract cost, including this supplement, is $\$ 855,900.00$. A construction project in this corridor is in the 8 Year Construction Work Plan with a scheduled letting date of FFY 2011. The total estimate for construction of this project is $\$ 12,860,800.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.

132. Director's Report

Director Ridley briefly discussed our 8 Year Construction Work Plan, and said we are planning to present this to the Commission in September or October.

Director Ridley introduced Chief Engineer, John Fuller, who provided a brief history of the Brifen cable barrier projects. He pointed out that the first Brifen cable barriers in the United States were installed on Lake Hefner Parkway here in Oklahoma City.

Director Ridley pointed out that through the efforts of Governor Henry and members of legislature we were able to add many cable barrier projects to our work plan. He discussed installation of the cable barriers and stated that we had needed to get the projects completed in a timely manner. Mr. Faria Emamian, Traffic Engineering Division, told the Director that he felt that our ODOT personnel could complete these cable barrier projects in the required time frame and not contract them out of the Agency. Mr. Emamian put together a team, which included some of our Survey Division people, and these projects were completed in the requested time line. Director Ridley thanked Faria and Survey Division personnel for all their efforts in completing these projects. Director Ridley said this is now known as the "Faria Cable."
